

I am a multidisciplinary artist and researcher who works under several different names as a result of being at risk of political persecution. As a transgender migrant, much of my work is autobiographical, journaling my experiences and the broader politics at play. I work across several disciplines, having a background in architecture and having worked across the cultural, research and human rights sectors. I write, make films, teach and investigate human rights abuses as part of my practice.
I have previously worked with established practitioners. I worked with Biennale of
(2017) which was subsequently exhibited at (2019) in Madrid, Spain. I also contributed research and animations for which was exhibited at the Biennale (2019). These collaborations are formative in my independent practice.
My practice has blossomed quickly since embarking on my own. Since mid- 2020, I have been on a year-long artist attachment with  funded by with an opportunity to exhibit work at the Biennale in 2022. That year I was also awarded a grant to co-curate an exhibition on racial conflict in by the British Council.
