AC has, since September 2011, staged contemporary and experimental projects and exhibitions alongside developing supportive and sustainable links within the business and arts community of Cardiff.

Central to the motivation behind the project is public access to the arts - both visibility and accessibility. We want to encourage a deeper understanding of, and fuller participation in, the arts - and an understanding of its role in everyday life - for businesses, the public and the wider arts audience. Due to our hyper-public location our audiences are large, wide-reaching and, in general, non-art. Alongside our exhibitions our programme consists of workshops, interactive activities, artist led groups, audio, spoken word and performance events.

1. What was your organisation's turnover in the last financial year?

The organisational turnover in 2019/20 was £51,000, with £3000 additional in kind support. £35,000 of this is ACW grants, with the remaining made up from trusts and foundations through project funding.

AC is mainly funded through an organisational large grant from Art Council Wales, and supported by several smaller funders - often but not limited to British Council, Cardiff and Vale University Health Board, Community Foundation Wales, Oakdale Trust, Heritage Lottery, Cardiff and Bath Spa Universities. It has an income stream through its studio group, Fairwater Studios, as well as occasional gallery hires, and payments for services such as talks and events. In the past Queens Arcade has made funding available for specific projects. Overheads for the project are low as Queens Arcade supports the project with two rent-free units within the shopping centre - an arrangement which has lasted for the last nine years.

In previous years AC has applied for a large grant at the May deadline, for an October start to the project. In this way across the last 6 years there has been no break in funding or activity at the gallery. As we are halfway through an active grant, and with the current lottery streams closed, we are unable to plan past 01 October 2020. As we work on a project by project basis we hold no reserves as an organisation - funds are allocated at the point of application and on receipt of funding.

By 'artist led' we assert that all of the staff and volunteers that run the space are practicing artists - and central to our way of working is to create opportunities for employment for artists in order to sustain their careers, as well as providing paying opportunities for exhibitions, residencies and events. Other than logistical requirements such as rent and utilities, all of our funding goes directly to artists.

2. Please tell us about how COVID-19 has affected your business and the financial losses that you have incurred

Tell us whatever you feel you're able to about what has happened to your organisation's fortunes as a result of COVID 19. (We're not able to support you through this fund if your change in circumstances is not related to losing income as a result of the COVID 19 pandemic.)

At the start of the crisis we made the early decision to close our studios, which are within a council owned complex and therefore share multiple entrance doors and exits with other companies. For the safety of our studio holders and other employees in the building we closed immediately, and at that point stopped charging studio fees. This was, we felt, the best way to support artists to continue their practice beyond Covid, by safeguarding any income or savings they have, and to alleviate financial strain and potential stress. Three of our studio holders are also parents, who would have been unable to use the studios due to new parenting responsibilities.

We have also faced a loss in project management fees associated with the British Council Italy Season, which has had to be cancelled due to the virus. While we are hoping this may be rescheduled for some time in 2021, for now all contracts have been rescinded. Similarly we have lost income through gallery bookings which will now no longer take place - most notably from the Magistrates Association booking which was due to take place in September.

Additionally we have honoured all of the contracts in place up until September, including staffing costs and artist fees. Some of the work we are able to postpone - assuming we can reopen before the end of the current grant. Some work can take place in a different form online. The staffing costs we are assuming as a loss unless admin or planning work can take place - we have set in motion a redesign of the website in order to host artwork in a new way. Similarly logistical contracts such as internet and electricity are still in place. This grant would support organisational running costs such as insurance and overheads to ensure we keep the space in kind.

Although we have honoured artist fees up to this point we are not able to commission new work at this moment - although a recently closed open call had over 80 applicants for two online residencies. This shows an urgent demand for artists to have a space to exhibit at this time - and also that many artists are still looking for paid opportunities where many have fallen away. It also demonstrates the reach, importance, and need of AC for the sector, as we continue to support artists. In terms of supporting the artist community in order for people to continue their practice post-Covid we feel it is imperative to continue to offer small scale accessible commissions at this time.

As with many other organisations we are now working from home, without a physical space to meet. This has an impact on the ability of the team to decision make, and overall productivity. We are experiencing difficulty in not having access to usual office equipment

especially around design and online connectivity.

3. Tell us about your organisation's work and its track record of working in the publicly funded arts and culture sector.

What has been the broad type and pattern of your previous work? What has been the public benefit of your work? What achievements would you particularly like to tell us about? AC has been presenting work in the public realm for the last nine years, working with emerging and established artists from Wales and internationally, to bring contemporary, experimental, exciting practice to a largely non arts audience. Resident in two shop units in the Queens Arcade shopping centre in central Cardiff, AC has strong links with the artistic, business, cultural and third sector communities across South Wales.

The broad focus of our work is supporting artists and presenting contemporary art in a setting that creates an alternative to the traditional gallery. As important to us as supporting artist practice is the audience we are delivering to, who in our hyper-public location include large numbers of people who would otherwise be unlikely to encounter or engage with contemporary art practice. We work hard to build relationships with third sector, health and community organisations with whom we programme and present work from less well served communities. Our strong long-standing relationship with the shopping centre has led to support in our audience development including free use of posters and digital screens across the centre, free use of equipment and support in staging out of hours performance and openings.

A recent successful and critically well received exhibition was 'A Brief History of Healing', working with artist Gail Howard, alongside in-patients, staff and visitors at the Hafan y Coed adult mental health ward at University Hospital Llandough. The exhibition was split across site, with the first launch taking place at AC, and the second a week later at the Hearth Gallery on the University Hospital site. Gail worked collaboratively with the patients to create work for the exhibition as well as creating new work herself, presenting these side by side in the gallery space. She also curated a series of artist workshops and residencies to work with the public in the shopping centre to think around mental health and wellbeing, culminating in a series of live events working with critically acclaimed artist and occupational therapist Georgia Twigg.

As directors of AC this was an important exhibition for us on many levels. It built networks within the arts and health sector, including securing funding from an NHS hospital trust. It showcased work from an artist with lived experience of mental health disabilities, and worked with her in a way that was supportive of her vision and ambition. It worked directly with patients that otherwise have no or very little access to creative endeavors while living full time in hospital, and showed their work alongside that of professional artists. Finally, it worked across sites to bring audiences to the very different gallery spaces, including health care professionals and the general public who would not have known about AC or the Hearth Gallery before this point. It was an aim that the cross-pollination of these audiences would grow both galleries audiences and bring about possible future commissioning possibilities.

Similar relationships have been built with organisations sure as the Trinity Centre - a centre for refugees and those seeking asylum in Cardiff. In Spring 2019 the Aurora Collective, a group of women formed at the Centre, staged a two week take over of the gallery space, turning it into a skill share and workshop space. Again we wanted to use the gallery as a platform for this community who usually do not have access to these spaces or resources, to develop and deliver a programme that comes from them and speaks to their communities and interests.

A more recent strand of collaborative working has been with Spit & Sawdust, a skatepark and artspace based in the east of Cardiff. In Autumn 2020 we were successful in a collaborative bid to British Council to undertake a research trip to Venice and Rome, where we met with potential partners for International collaboration. We were successful in gaining further funding to run a residency in Venice with artist and musician Emma Daman Thomas, however due to the recent crisis this is currently on hold.

Recently AC has further developed its relationship with Yellow Back Books - an artist book project run by Clare Charles and George Manson, in collaboration with Becca Thomas, Freya Dooley and Louise Hobson, with a section of Campfa's exhibition space currently given over to the project to exhibit and sell from their artist book collection. In this way, AC supports Yellow Back Books with a commercial location, contextualising the collection and bringing it new audiences. It also offers artists, including many young or emerging Wales based artists working with books or printed material, the opportunity to display alongside international artist's books, as well as a potential income stream from selling their work.

4. What difference will an emergency grant from this fund make to your organisation, and how might you use it within the next six months?

AC consists of a small team of artists/co-directors Clare Charles and George Manson, artist/volunteer coordinator Molly Sinclair Thomson, and the extended artist network across Wales. AC supports these practitioners through freelance employment, alongside free community workshops and activities, artist talks, residencies and networking opportunities. AC volunteers are showcased on the website, and receive a weekly email highlighting opportunities within the cultural sector. This grant would enable AC to continue to deliver during lockdown ensuring support for this community while shaping ourselves digitally for accessibility, resilience and sustainability.

AC feels it is important to continue to support artists throughout the crisis with paid opportunities to show work, alongside digital crits and opportunities to network and expand their practice where possible. This fund would enable us to continue to commission new digital work, supporting the artist community and sustaining practice during this critical period.

The fund would also allow us to develop our digital presence and audiences, and find new ways to connect with people who cannot physically visit the space. We want to expand our digital strategy - looking at new ways of working with our existing audiences and new ways of supporting artists, while keeping the momentum of the programme and supporting the creative community to survive. Furthermore, developing our digital presence would be of

long term benefit, beyond Covid, to our audiences, our accessibility, and how we support and serve the artists we work with, through online promotion and archiving of their work.

Although our recent call out has been very successful, with over 80 applications, we still lack a strong link with the disabled art community. We want to specifically work with disabled artists for whom this lockdown is a long-term reality, and whose insights will be vital in how we as a community move forward in the new normal. This fund would allow us to develop those connections and commission two online exhibitions or residencies specifically for disabled artists.

Working from home has brought up new challenges for the organisation, no least in developing our digital reach. The fund would buy us essential equipment to develop the website and our ability to host and display artists work in the digital realm. It would buy both physical equipment and affordable software packages (one off purchase rather than subscription) to enable us to reach our ambitions for digital exhibitions.

In essence the fund would allow us to continue to be a viable and valuable presence in support of the emerging artist community through this period, rather than being fallow until the Autumn. We feel we are a vital part of the ecology of the arts in South Wales, and therefore want to continue to be available and a viable organisation and resource during the next six months and beyond.

5. Are you seeking financial assistance from anywhere else? Do you expect to be successful?

Despite thorough research we have been unable to identify any other funds that will support us in this way, at this time. We will continue to be vigilant in our research, and to apply for any opportunities that are available to us.

6. Your Project Proposal

We want to build on the momentum that ambitious projects such as Brief History of Healing has brought to the organisation, and to continue to support the important emerging artist ecology in Wales. The grant would support us in driving debates around accessibility of art to lesser served audiences - and in highlighting artists who are less able to access opportunities within the art world - working towards the benefit of all.

The grant would be used to ensure artists are supported and strengthened through this precarious period and into the future, and that freelance artists are employed to work with them to do this. We want to celebrate the creative community and also stay connected to them - as without them AC would not exist.

The gallery and project space are housed in the centre of Cardiff in a shopping arcade that tends to be utilised by people who suffer economic hardship - other shops include discount hairdressers, a comic shop that largely functions online and a pop up children's soft play that only functions during the holidays. As such AC is constantly thinking of accessibility and opportunities for low income audiences to access culture. This fund will help AC continue a programme of freely accessible exhibitions and workshops and will give time and space to think on how we can use the digital realm to reach these audiences. Staying

digitally connected will support the continuation of the programme in our busy high street space once it is safe to do so. AC has a strong relationship with the landlord who waives our rent and wants to support AC to continue dissolving barriers between artists and the public. This includes exhibitions around relatable themes and with opportunities for the public to show their own work, develop their creativity, adding to the sector's creative and cultural diversity.

The research and development time this support would afford means the organisation will emerge from the crisis more robust and sustainable - and with a clearer idea of how to reach audiences outside of the physical programme. We will continue to collaborate and share resources with peers and collaborators. We will support creative practitioners and art ecosystems through paying artists in this time of economic hardship.

The setting up of a home office which includes the technology to create and design web based graphics will have a huge impact on our ability to present work, the fluidity of our working practices, and on the skills base of our designer, who will be able to familiarise themselves with the latest available technology. The costings presented are based on buying refurbished rather than new, and based on using Mac software which is the industry standard.
